## **RESOLUTION NO. 2029**

## A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF ROSS PROPOSING THAT AN ELECTION BE HELD IN ITS JURISDICTION ON JUNE 5, 2018; REQUESTING THE MARIN COUNTY BOARD OF SUPERVISORS TO CONSOLIDATE WITH THE GENERAL ELECTION CONDUCTED ON THAT DATE; AND REQUESTING ELECTION SERVICES OF THE COUNTY ELECTIONS DEPARTMENT

WHEREAS, a general election is scheduled to be held on June 5, 2018; and

WHEREAS, terms of office on the Ross Town Council will expire in June 2018, for those seats now held by Elizabeth Robbins and P. Rupert Russell. In addition, a two-year remaining term of office seat vacated by Kathleen Hoertkorn, and now held by appointed Council Member Julie McMillan, shall be put to the voters. These officers shall hold office for their prescribed terms until the Council adopts the official canvass of the June 5, 2018 election; and

**WHEREAS**, pursuant to Section 10002 of the Elections Code, the above-stated governing body may request the Board of Supervisors to permit the County Elections Department to render specified services to said Body relating to the conduct of the election on a reimbursable basis; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the Town of Ross as follows:

- 1. That an election is hereby called to be held on June 5, 2018, at which election two (2) Council seats for a four-term, and one (1) Council seat for a two-year term shall be determined by the voters; and
- 2. That the Board of Supervisors of the County of Marin is hereby requested to consolidate said election with the general election to be conducted on the same day; and
- 3. That the Town Council hereby acknowledges that the consolidated election will be held and conducted in the manner prescribed in Section 10418 of the California Elections Code; and
- 4. That the Board of Supervisors of the County of Marin is hereby requested to authorize the County Elections Department to render the following specified services for said Body relating to the conduct of the election to be held on June 5, 2018: Preparation of voter indexes; voter counting by precinct; verification of signatures; drayage and rental of polling places; printing of measures and arguments; printing of sample and official ballots; appointment and notification of election officers; mailing of sample ballots and polling place notification; provision of precinct supplies; training of precinct workers; processing of absentee ballots; central counting; canvass of votes cast; and
